### Please Note:

Vendors must be completely set up and have vehicles parked in the public area by 7:15 am on Saturday 4/30. Non-compliance with these terms will result in your not being permitted to enter to set up on the first day of the event. If it is determined that your arrival time is too late for you to unload, set up or you will be denied entry. No refunds or adjustments will be made if you are excluded from set up on any day or elimination from entry and set up for the entire weekend. Each vendor must comply with the space allowance purchased. **No exceptions to these terms will be permitted.**

*Please be specific about your merchandise. We try not to duplicate items.* Use the back of this page if more space is needed for description of merchandise or any other purpose necessary for clarification of requests.

**This application must be received by the deadline date of April 18**, complete with full payment and completely filled out. Any deviation from the terms set forth in this contract/application will result in your application being denied. All checks must be cleared before anyone will be approved or permitted to set up.



**If you are denied** vendor space, your money will be refunded upon denial. Causes for denial: Incomplete application, missed the deadline; other vendors selling similar products got their application and money in before you, inappropriate merchandise such as any X rated or pornographic products, products deemed inappropriate for our audience.

**If you neglect** to properly describe your merchandise and it is in conflict with another vendor, you will be asked to remove for sale such merchandise or close up shop immediately and leave at the end of the day. No dismantling will be permitted during conference hours. No refunds or adjustments will be made.

**Vendors are encouraged** to mail pictures of your merchandise. The selection of vendors is based on several factors and pictures are worth a thousand words.
